## Candidate/Delegate Filing Dates

The filing period for 2008 candidates is from January 23 to February 22, 2008. All candidates for public office up for election in Warrick County in 2008 must file their declaration of candidacy with the Clerk's Office during this time.

Anyone wanting to run for precinct committeeman must also file his/her declaration of candidacy during this period.

Finally, Warrick County has been allotted 25 delegates for the State Convention which is scheduled for June 1 & 2. 17 delegates will be elected at large, and 8 from districts – 2 from each County Council district. The primary reason we have set things up this way is to avoid conflicts between candidates for the convention and poll workers on election day. To avoid such conflicts, please contact a member of the central committee before filing so that he/she may advise you on potential conflicts with poll workers that may arise.
